2011-12 Trips



Experience a cross-cultural adventure while serving others

The mission of Interfaith Service to Latin America (ISLA) is partnering to create self-sustaining communities in Latin American through health, education and construction programs. We carry out our mission by sending short term teams to work with the community on various projects, providing opportunities for cultural exchange.

Volunteers work in partnership with local citizens and organizations to undertake projects that benefit the community. We value each human being we meet and serve all persons regardless of race, creed, and social or economic status placing particular emphasis on serving the poorest and neediest. We strive to provide an enriching spiritual experience as we work, play and grow together.

Programs

ISLA carries out its mission through three programs: medical, educational and construction. All of the 2011-12 teams will be working in Jalapa, Nicaragua located in north central Nicaragua. ISLA teams consist of 5 to 35 volunteers plus a trained team leader.

The Volunteer

People of all backgrounds and experiences travel with ISLA including families. The minimum age to participate is 14 years old and a parent or guardian must accompany youth under the age of 18.

If you are culturally sensitive, flexible, optimistic, willing to learn, work well in a team setting, and are open to new experiences, you should find this a very rewarding experience.

Living Accommodations

Teams stay in a local hotel. The rooms have bathrooms with showers. Our food is typical Nicaraguan fare and is prepared by and served family style at local restaurant. Internet cafes are available in Jalapa and telephone service is available at the hotel.

Trip Preparations

Volunteers receive a Volunteer Manual. In addition, a formal orientation session is held several weeks prior to the trip where information is provided on work projects, health, safety, travel arrangements, packing list, travel tips, group guidelines, reading list, and cross-cultural awareness.

Cost

The current cost per person for a 2011-12 trip is \$1450.00 **plus** airfare. The trip fee includes in-country travel, lodging, most meals, orientation materials, travel accident and evacuation insurance, project/program costs and administrative expenses. Costs incurred during free time activities are additional and the responsibility of the volunteer.

Available Trip Fee Discounts

ONLY ONE TYPE OF DISCOUNT WILL APPLY PER APPLICATION

Student discount: \$200 discount per person.

Proof of full-time student status must be sent with application and full deposit.

Family discounts:

Family of 2, \$100 discount per person, \$200 maximum discount per family

Family of 3, \$150 discount per person, \$300 maximum discount per family

Family of 4 or more, \$200 discount per person, \$800 maximum discount per family (Family discounts apply to two or more people who have the same primary resident address.)

Returnee discount:

Anyone going on a second trip within the same 12-month period is eligible for a \$100 trip discount.

ISLA can make your flight arrangements. If ISLA arranges your flight, the full amount of the airfare must be paid prior to the time of booking. Participants may arrange their own air travel, however, prior to making your reservations please check with the ISLA office for the preferred flight schedule.

The cost of the trip is tax-deductible to the full extent of the law.

Registration

If you would like to join a team, please complete and sign the application/ISLA Trip Agreement and send with two copies of your passport and your non refundable \$200 deposit to the ISLA office. Space is limited, so early registration is encouraged.
